\*\*\*\* In case the party who is a Hungarian national does not have a valid Hungarian passport, identity card or nationality certificate, the registration of the marriage can take place only after the Hungarian nationality has been established by submitting the documents to the Office of Immigration and Nationality’s Nationality Directorate for a nationality check. The nationality of the foreign party has to be proved as well (by presenting copy of his/her passport, national identity card, etc.)
